3. You will make no entries in this book, except to sign your name on pages 3 and 7, and to make your will, if you so desire, on page 18.
4. Should you lose your book you will at once report the loss to your Commanding Officer. A new book will be obtained, if possible, from the Accountant, but it must be understood that no pay can be issued in respect of the period before the date on which you report the loss until you are finally settled with.
