The photographs must be on thin paper, should have a light background, and be not over three inches in size.

This blank must be completely filled out. The legal fee of nine dollars in currency or postal money order, and the applicant's certificate of naturalization must accompany the application. The rules should be carefully read before mailing the application to the Department of State, Division of Passport Control, Washington, D. C.
