INOUEST ON LEONARD WALKER

That Leonard Arthur Walker died from sudden heart failure was the verdict of the coroner, Mr J. R. Bartholomew, S.M., at the adjourned inquest yesterday on the deceased, who had collapsed and died almost immediately after entering the bar of an hotel in the city on September 5. Walker, who was a returned soldier, 39 years of age, was a married man with a family, and resided at 532 Castle street. He had previously been under the care of a doctor.

Sergeant Boulton conducted the case on behalf of the police.

John Antony Walsh, a barman,

said that while the deceased was lying on a couch in the hotel he tried to get Walker to take some brandy, as he thought that he had fainted. The man's breathing was very faint, and he died before the police and a doctor arrived.

Neil Donaldson stated that when he and Walker went into the hotel Walker appeared to be sober and in good health. He had known Walker for about 10 years, and the deceased did not appear to be suffering from any illness during that time.

Dr E. F. D'Ath, pathologist at the Medical School, said that from a post mortem examination he had formed the opinion that the deceased died of sudden heart failure, the result of extensive damage to the heart muscles and valves from a previous attack of rheumatic

The coroner, after reviewing the evidence, returned a verdict in accordance with the medical evidence.
